

PARTICIPANT CODE OF CONDUCT

Participants are responsible for knowing and following George Mason University's Participant Code of Conduct. Participants attending for credit programs or a program as an admitted student must also follow Mason's [Student Code of Conduct](#).

As a participant I agree to the following:

1. I will obey all applicable University policies and any and all rules or regulations issued by the Camp/Program Director and the University.
2. I will demonstrate cooperation and respect to Program Staff and Participants as well as University employees, students and visitors.
3. I will not harass (verbally, electronically, or through other means) any other individual. I will not knowingly or intentionally physically harm other participants or Program Staff. I understand that hitting, pushing, kicking, fighting, bullying, and other behavior which may harm another person will not be tolerated.
4. I will respect the property of other Participants, Program Staff, and George Mason University. I will not take anything that does not belong to me. I will not knowingly or intentionally deface or destroy campus property, the property of others, or nature.
5. I will follow all the safety rules and regulations given for each activity in which I participate. This includes, but is not limited to, following the rules regarding curfew, lights out, and being at my assigned activity at the assigned time.
6. I understand that the possession and use of illegal drugs, alcohol, or tobacco at a Camp/Program is unacceptable and prohibited.
7. I understand that any medication which I require to treat a medical condition will be collected and administered by the Program Staff, in accordance with the [Code of Virginia](#), and I agree that I will not share my medication with others.
8. I understand that I should inform Program Staff of any personal injury or medical condition which could affect my ability to fully participate.
9. I understand that I must inform Program Staff if I am having a problem with, or feeling threatened by, another Participant, a member of the Program Staff, or anyone I encounter.
10. I understand that I must wear appropriate clothing each day, and that what clothing is deemed appropriate or inappropriate is at the discretion of Program Staff.
11. I understand that weapons, look-alike weapons, or objects that may be used to threaten, intimidate, or harm others or to damage property may not be brought to a camp/program. Any object that may hurt or place another person in fear of his/her safety may be considered a weapon and bringing that item to a camp/program is grounds for immediate disciplinary action, including suspension or dismissal.

As a participant I agree to the following COVID-19 precautions:

1. I agree to follow the guidelines provided in George Mason University's [Safe Return to Campus Plan](#) and University Policies, instructions, and signage regarding limiting the spread of COVID-19.
2. I agree to maintain physical distancing between myself and others, including distancing from Program Staff.
3. I agree to comply with [Mason's Face Covering Policy](#), which requires wearing a face covering when on campus, except in limited circumstances (e.g., while eating or drinking).
4. I agree to complete Mason Covid Health Check daily and agree to stay home if I become symptomatic or known to have been or believed to have been exposed to COVID-19.
